

VICART ENTERTAINMENT PRIVACY POLICY

VICART ENTERTAINMENT (“VICART ENTERTAINMENT”) takes your privacy very seriously. Please read the following to learn more about VICART ENTERTAINMENT's Privacy Policy ("Policy"). This Policy details how VICART ENTERTAINMENT receives, collects and uses information in connection with its website ("Site").

1. Collection and Use of Information

VICART ENTERTAINMENT collects and stores information from you in several ways on different parts of the Site.

Information You Provide:

In the event VICART ENTERTAINMENT makes registration on its Site available to you, you may be asked to provide personally identifiable information, which may include your name, email address, address, telephone number(s), login name, login password and other self-identifying information (all "Personal Information"), as well as certain other non-personally identifiable information, such as age, gender and areas of interest when you register on the Site. In addition, VICART ENTERTAINMENT may also collect information about the searches you perform, promotional offers you choose and the pages you visit on the Site. VICART ENTERTAINMENT collects Personal Information primarily for the following purposes: (i) to maintain a record of registered users, (ii) to email registered users with news and updates, which may include offers and promotions.

In the event VICART ENTERTAINMENT makes message boards and forums available to you (collectively, "Forums"). You are solely responsible for the information and other content you post on and through these Forums and should be aware that when you voluntarily disclose personal information (e.g., name, e-mail address, telephone number) on or through these Forums, such information is generally accessible to, and may be collected and used by, other users. VICART ENTERTAINMENT does not exercise control over any users or Site visitors, and is in no way responsible, and has not liability whatsoever, for any collection or use of information you may disclose through the Forums. This Policy does not cover such disclosure of information. You are encouraged to exercise discretion when providing personal information about yourself in and through Forums.

Information We Automatically Collect:

VICART ENTERTAINMENT automatically receives and records certain non-personally identifiable information on its server logs from your browser, including your IP address, cookie information, and the webpage that you visit. VICART ENTERTAINMENT collects non-personally identifiable and demographic information for general purposes, including but not limited to increasing the relevance of the Site to our users, and customizing the advertising, promotional messages and content you see, as well as conducting research, and providing

anonymous reporting to internal and external clients. Our server logs do not record any Personal Information.

2. Cookies:

Cookies are pieces of information a web site can send to your computer's browser for record-keeping purposes. We use cookies to ascertain which web pages are visited and how often, to make our Site more user friendly, and to give you a better experience when you return to the Site. Most web browsers automatically accept cookies, but you do not have to accept them. To disable cookies, you should access the "help" tab on your browser or read the information that came with your browser software. However, your visit to our Site will be significantly enhanced if cookies are not disabled.

3. Our Use of Your Personal Information:

We may use your Personal Information to send directly to you email and other communications with VICART ENTERTAINMENT announcements, special offers and other promotional information. Out of respect for your privacy, we provide you with an option to discontinue receiving such promotional emails directly from VICART ENTERTAINMENT by following the instructions in any promotional email you receive from us.

In addition, we will occasionally need to use your Personal Information to communicate with you by email in response to your inquiries, to provide the services you request, to manage your account and to inform you of service related to our Site operations. You will continue to receive service announcements and responses to your inquiries even if you opt out of receiving our promotional emails.

4. Sharing and Disclosure of Information:

VICART ENTERTAINMENT does not rent, sell, or share Personal Information with other non-affiliated third-parties. VICART ENTERTAINMENT may disclose Personal Information under the following circumstances:

1. VICART ENTERTAINMENT may provide Personal Information to trusted third-parties who work on behalf of or with VICART ENTERTAINMENT. VICART ENTERTAINMENT attempts to ensure that such companies agree to maintain confidentiality, security and integrity of the Personal Information obtained from VICART ENTERTAINMENT. These companies do not have any independent right to share the Personal Information.
2. VICART ENTERTAINMENT may disclose, sell or transfer Personal Information in connection with an assignment, sale, joint venture, or other corporate transfer or disposition of some or all of VICART ENTERTAINMENT's assets.
3. At times VICART ENTERTAINMENT may be required by law or litigation to disclose your Personal Information. We may also disclose information about you if we determine that for national security, law enforcement, or other issues of public importance that disclosure of information is necessary.

5. Children's Privacy:

Protecting the privacy of the very young is especially important. We operate our website in compliance with the Children's Online Privacy Protection Act (COPPA). VICART ENTERTAINMENT does not knowingly, directly or indirectly, collect or maintain Personal Information at or on our website from children under the age of 13. No part of the Site is directed at or structured to attract anyone under 13.

6. Security:

VICART ENTERTAINMENT takes reasonable precaution to protect Personal Information from misuse, loss and unauthorized access. Although VICART ENTERTAINMENT cannot guarantee that Personal Information will not be subject to unauthorized access, VICART ENTERTAINMENT has physical, electronic, and procedural safeguards to protect the Personal Information. Personal Information is protected by secured networks and access is limited to a few authorized employees and personnel.

7. Changes to Policy:

From time to time, VICART ENTERTAINMENT may revise this Policy. VICART ENTERTAINMENT will post the revised Policy on the Site, so that you can always be aware of what information VICART ENTERTAINMENT collects, how the information is used and under what circumstances such information may be disclosed.

8. Other Websites:

VICART ENTERTAINMENT may provide links to various third-party websites from the Site. VICART ENTERTAINMENT has no control over these linked sites, each of which has a separate privacy and data collection practice, independent of VICART ENTERTAINMENT. As such, VICART ENTERTAINMENT is not responsible for, or has no control over, the content or the privacy policies of these third-party websites. VICART ENTERTAINMENT encourages you to read the privacy policies of each and every website that you visit when linking from the Site. This Policy applies solely to information collected by VICART ENTERTAINMENT.
